

# MUSIC LICENCE FORM - TARIFF 10A – STROLLING MUSICIANS AND BUSKERS; RECORDED MUSIC in PARKS, STREETS and OTHER PUBLIC AREAS

- Grants you permission to play (publicly perform) musical works by strolling musicians and buskers or by means of recorded music in parks, streets and other public areas
- Fee is \$32.55 for each day music is performed (up to a maximum of \$222.93 per three-month period) + taxes
- For concert performances in parks, streets or other public areas, see [Tariff 4](#)
- Deadline for SOCAN to receive forms and payments is the end of the calendar quarter

The legal terms that govern your licence include those set out herein as well as those found in the approved tariff including the General Provisions, as approved by the Copyright Board of Canada for each year (collectively, the “*tariff*”). 1. In this form, *you, your* and *licensee* means the person or company applying for a licence or filing an annual report. *We, our, us* and *SOCAN* means the Society of Composers, Authors and Music Publishers of Canada. *Works* means any or all of the musical works in SOCAN’s repertoire.

3. If the tariff for a year has not been approved by January 1<sup>st</sup> of that year, the last approved tariff will govern until the new tariff is approved, at which time the annual licence fees will be adjusted or reflect the approved tariff for the year.
4. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
5. You will keep records of all information required to calculate the licence fees.
6. Licence fees and Music Licence forms are due prior to the event.
