

# MUSIC LICENCE FORM - TARIFF 10B –MARCHING BANDS or FLOATS WITH MUSIC PARTICIPATING in a PARADE

- Grants you permission to play (publicly perform) musical works by marching bands or floats (with music) participating in parades
- Licence fee for each parade is \$9.42 for each marching band or float with music participating in the parade (minimum fee is \$34.93 per day) + taxes
- Deadline for SOCAN to receive forms and payments is the end of the calendar quarter

1. In this form, *you, your* and *licensee* means the person or company applying for a licence or filing an annual report. *We, our, us* and *SOCAN* means the Society of Composers, Authors and Music Publishers of Canada. *Works* means any or all of the musical works in SOCAN’s repertoire.

3. If the tariff for a year has not been approved by January 1<sup>st</sup> of that year, the last approved tariff will govern until the new tariff is approved, at which time the licence fees will be adjusted to reflect the approved tariff for the year.
4. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
5. You will keep records of all information required to calculate the licence fees.
6. Licence fees and Music Licence forms are due prior to the event.
