

- Grants you permission to play musical works at exhibitions and fairs; for music at concerts for which an additional admission is charged, Tariff 5B applies
- Annual fee is based on the total attendance to the event and/or the # of days of the event (see table on the right) + taxes
- Deadline for SOCAN to receive forms and payments is no later than January 31<sup>st</sup> ▲ of the year for which the licence is granted for annual events (calculation based on previous year's attendance), or within 30 days of the closing for non-annual events (▲ except for first time reports)

The legal terms that govern your licence include those set out herein as well as those found in the approved tariff including the General Provisions, as approved by the Copyright Board of Canada for each year (collectively, the “tariff”). 1. In this form, *you*, *your* and *licensee* means the person or company applying for a licence or filing an annual report. *We*, *our*, *us* and *SOCAN* means the Society of Composers, Authors and Music Publishers of Canada. *Works* means any or all of the musical works in SOCAN’s repertoire.
2. A copy of any SOCAN tariff may be obtained by emailing [licence@socan.ca](mailto:licence@socan.ca) or calling 1.866.944.6223.
3. If you are applying for a licence, SOCAN will process your application within 30 days of receipt and contact you in the event that your application is not approved. If you already have a licence under this tariff, this is your annual report.
4. If the tariff for a year has not been approved by January 1<sup>st</sup> of that year, the last approved tariff will govern until the new tariff is approved, at which time the licence fees will be adjusted to reflect the approved tariff for the year.
5. This licence will renew automatically on January 1<sup>st</sup> for each year unless terminated by either party upon 30 days notice in writing.
6. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
7. You will keep records of all information required to calculate the licence fees.
8. In the case of an annual exhibition or fair, licence fees and report forms are due no later than January 31<sup>st</sup> of the current year within ten days of any adjustments. In all other cases, licence fees and Music Licence forms are due within 30 days of the exhibition or the fair’s closing.
