

MUSIC LICENCE FORM - TARIFF 6 – MOTION PICTURE THEATRES



- Grants you permission to play (publicly perform) musical works in your motion picture theatre (or any establishment exhibiting motion pictures), including drive-ins
- Annual fee is based on a fee per seat, per screen (see table) + taxes, subject to minimum fee. The seating capacity of drive-in theatres is deemed three times the maximum number of car that can be accommodated at one time
- Theatres operating less than 4 days per week pay one half of this rate and seasonal theatres operating less than 12 months per year are prorated based on the number of months of operation per year
- Deadline for SOCAN to receive forms and payments is January 31st of the year for which a licence is granted (except for first time reports)

The legal terms that govern your licence include those set out herein as well as those found in the approved tariff including the General Provisions, as approved by the Copyright Board of Canada for each year (collectively, the “tariff”). If you have any questions regarding the terms, please [contact us](#).

1. In this form, *you, your* and *licensee* means the person or company applying for a licence or filing an annual report. *We, our, us* and *SOCAN* means the Society of Composers, Authors and Music Publishers of Canada. *Works* means any or all of the musical works in SOCAN’s repertoire.
2. A copy of any SOCAN tariff may be obtained by emailing licence@socan.ca or calling 1.866.944.6223.
3. If you are applying for a licence, SOCAN will process your application within 30 days of receipt and contact you in the event that your application is not approved. If you already have a licence under the SOCAN tariff(s) listed on the reverse, this is your annual report.
4. If the tariff for a year has not been approved by January 1st of that year, the last approved tariff will govern until the new tariff is approved, at which time the licence fees will be adjusted to reflect the approved tariff for the year.
5. This licence fee will renew automatically on January 1st for each year unless terminated by either party upon 30 days notice in writing.
6. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
7. You will keep records of all information required to calculate the licence fees.
8. Licence fees and report forms are due no later than January 31st of each year or within 10 days of any adjustments.
