## MUSIC LICENCE FORM - TARIFF 6 - MOTION PICTURE THEATRES



- Grants you permission to play (publicly perform) musical works in your motion picture theatre (or any establishment exhibiting motion pictures), including drive-ins
- Annual fee is based on a fee per seat, per screen (see table) + taxes, subject to minimum fee. The seating capacity of drive-in theatres is deemed three times the maximum number of cars that may be accommodated at one time
- Theatres operating 3 days or less per week pay one half of the rate and seasonal theatres operating less than 12 months per year are prorated based on the number of months of operation per year
- Deadline for SOCAN to receive forms and payments is January 31st of the year for which a licence is granted (except for first time reports)

- 5. The licence fee, plus applicable taxes, will be calculated in accordance with the terms of this licence based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
- 6. You will keep records of all information required to calculate the licence fees.
- 7. The licence fees and report forms are due no later than January 31st of the year covered by the licence, or within ten days of any adjustments.
