

# MUSIC LICENCE FORM - TARIFF 8 – RECEPTIONS, CONVENTIONS, ASSEMBLIES AND FASHION SHOWS



- Grants you permission to play (publicly perform) musical works at receptions, conventions, assemblies, and fashion shows
- Per event fee is based on (1) the capacity (seating and standing) of each room <sup>▲</sup> and (2) whether music is used for dancing or not (+ taxes)
- <sup>▲</sup> Capacity authorized under the establishment's liquor licence or any other document issued by a competent authority
- Deadline for SOCAN to receive forms and payments is 30 days after the end of the calendar quarter in which the music use occurred

1. In this form, *you*, *your* and *licensee* means the person or company applying for a licence or filing an annual report. *We*, *our*, *us* and *SOCAN* means the Society of Composers, Authors and Music Publishers of Canada. *Works* means any or all of the musical works in SOCAN's repertoire.
2. A copy of any SOCAN tariff may be obtained by emailing [licence@socan.ca](mailto:licence@socan.ca) or calling 1.866.944.6223.
3. If you are applying for a licence, SOCAN will process your application within 30 days of receipt and contact you in the event that your application is not approved. If you already have a licence under this tariff, this is your quarterly report.
4. If the tariff for a year has not been approved by January 1<sup>st</sup> of that year, the last approved tariff will govern until the new tariff is approved, at which time the licence fees will be adjusted to reflect the approved tariff for the year.
5. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
6. You will keep records of all information required to calculate the licence fees.
7. Deadline for SOCAN to receive forms and payments is 30 days after the end of the calendar quarter in which the music use occurred.
