- 4. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.

- 5. We have the right to audit your books and records, on reasonable notice and during normal business hours, to verify your statements and licence fee.
- 6. You will keep records of all information required to calculate the licence fees for each year.
- 7. Licence fees and report forms are due on or before January 31st of the year covered by the licence or within 10 days of any adjustments.
