In this form, *you, your* and *licensee* means the person or company applying for a licence or filing an annual report. *We, our, us* and *SOCAN* means the Society of Composers, Authors and Music Publishers of Canada. *Works* means any or all of the musical works in SOCAN's repertoire.

If you are applying for a licence, SOCAN will process your application within 30 days of receipt and contact you in the event that your application is not approved. If you already have a licence under SOCAN Tariff 7, this is your annual report.

A Tariff 7 licence gives you the right to publicly perform live and recorded *Works* in connection with roller or ice skating. Please complete and attach a separate application for each venue.

If you have a licence under Tariff 21, you may not need to apply for a licence under Tariff 7. Please contact us if you have other music uses. You may need to be licensed under other tariffs.

**How to calculate your licence fee**

The licence fee is a percentage of the gross annual receipts from admissions for the previous year (excluding sales and amusement taxes). Provide us with the actual gross annual receipts from admissions or, if you have not previously used music in connection with roller or ice skating, provide us with your estimate of gross annual receipts from admissions during the coming year. The minimum annual licence fee is **\$104.31**.

## Terms of this licence

The legal terms that govern your licence include those set out herein as well as the terms found in the approved tariff including the General Provisions, as approved by the Copyright Board for each year (collectively, the *tariff*). If you have any questions regarding the terms, please contact us at the address and numbers shown at the bottom of this page.

1. If the tariff for a year has not been approved by January 1<sup>st</sup> of that year, the last approved tariff will govern until the new version is approved, at which time the annual licence fees will be adjusted to reflect the approved version for the year.
2. A copy of any tariff may be obtained from SOCAN by calling **1.866.944.6223**.
3. This licence will renew automatically on January 1<sup>st</sup> of the following year for a 12-month period unless terminated by either party upon 30 days notice in writing.
4. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
5. We have the right to audit your books and records, on reasonable notice and during normal business hours, to verify your statements and licence fee.
6. You will keep records of all information required to calculate the licence fees for each year.
7. No later than January 31<sup>st</sup> of the year for which this licence is issued, you will file with SOCAN a report estimating the gross receipts from admissions based on the actual total gross receipts from admissions from the previous year, and shall pay those estimated fees for the year for which the licence is issued.
8. Report forms of the actual gross receipts from admissions and payment of any adjustment of the licence fees are due January 31<sup>st</sup> of the year following the year for which the licence is issued or within 10 days of any adjustments.
