Agreement Types

Specific: The assignee in the agreement is entitled to collect a publishing share for only those musical works that are specified by either the assignor or assignee

General with Exclusions: The assignee in the agreement is entitled to collect a publishing share for all of the musical works in the assignor's catalogue with the exception of those that are specifically excluded from the agreement

Pipeline Monies

Any money that is distributed to SOCAN for a time period that precedes the start date of the agreement, but has not yet been distributed to the assignor
